A- Services

- 1- Safari diving trips.
- 2- Equipment rental.*
- 3- Diving & Snorkeling courses.*
- 4- IDC or ITC.
- 5- Underwater photography & video.

B- Requested documents

- 1- Maritime Safety Authority license
- 2- Commercial registration if the owner is a company *
- 3- Name & certification of the technical manager. *
- 4- Equipment inventory –if applicable -including: masks, snorkels, fins, BCD s, suits, regulators, weight belts, weights, MFA, O2 kits, tanks & compressor(s) all with code numbers & serial numbers if applicable. *
- 5- Air quality test certificate.(**recommended**)
- 6- Employees files with job titles.*

C- Vessel

- 1- Wireless communication device (VHF radio)(**Recommended**)
- 2- Mobil Telephones
- 3- Instruction bulletin board including: safe diving practice, environmental awareness signs/ stickers, price list, insurance policy if available.*
- 4- Guests comment box.
- 5- Guests' equipment storing area with good ventilation.*
- 6- Rinsing basin
- 7- Minimum one Compressor with a minimum capacity of 250 Liters/min.
- 8- Bathrooms (min. 2)*
- 9- Quick repairs & maintenance kits
- 10- Minimum one inboard Electric power generator.
- 11- Minimum one RIB/inflatable with eng

D- Equipment

- 1- Weight belts with quick release buckle (one belt per guest).*
- 2- 10 kgs of lead weights per guest.*
- 3- Medic first aid kit suitable for diving application.*
- 4- O2 kit suitable for delivering 15 liter/ minute flow for minimum 20 minutes.*
- 5- 1.3 Tanks per guest of 12 liters or 80 CFT.(valid Hydro test date is a must)

- 6- Air compressor (s) with a minimum capacity of 250 liters/ minute.
(Working hours gauge **recommended**)
- 7- Life vests (suitable to the number of guests & crew)

E- Files

- 1- Trips lists with guests and crew names.*
- 2- Guest information documents including: name, address, nationality, passport number, birth date, medical statement, liability release & services provided all signed by the guest.*
- 3- Employee's files & titles.*
- 4- Equipment inventory if applicable
- 5- Equipment maintenance record file.*
- 6- Compressor maintenance & operation files.*
- 7- Tanks validity, maintenance & test record file.*

F- Staff

- 1- Technical responsible Manager: holding an instructor license (Second level+ 2 years experience) & CDWS card.*
- 2- Dive guides holding a professional diving license with good command of foreign language & CDWS card*
- 3- Trained Compressor operator. *
- 4- Trained gas blender in case of the availability of a gas blending station (Nitrox/Trimix).

NB: All fields are obligatory for new certifications except the recommended fields.
