

The CDWS, represented by its chairman, as the head of the legal committee along with the legal advisors of the Egyptian Tourism Federation and the Ministry of Tourism are currently working on drafting and legislations amendments related to the diving and water sports sector. Through analyzing and studying laws that aim to complete, develop and renew the legislative, regulatory and administrative frameworks for diving and water sports activities. The law will help in eliminating the challenges and obstacles facing the touristic establishments and to serve the best interest of the CDWS members.

As per the law, the administration of the CDWS runs on three different levels: .

#### First: The CDWS General Assembly:

Includes all the CDWS members from the legal touristic establishments that hold a valid license from the Ministry of Tourism, such as diving centers, water sports centers, and safari boats.

The CDWS is a member of the Egyptian Tourism Federation and has 20 general assembly members representing it in the general assembly of the Egyptian Tourism Federation.

#### Second: the CDWS board of directors:

The board has 12 members, 8 elected by the members of the general assembly and 4 members appointed by the Ministry of Tourism.

The board holds regular meetings, that are attended by a representative from the Ministry of Tourism and a representative from the Egyptian Tourism Federation. The administrative committee of both CDWS offices attend the meetings, in which they share their recommendations to the CDWS board of directors.

#### Third: Substantive committees, and their appointed heads:

#### Fourth: There is a management committee for each branch.

These committees work on evaluating the challenges and obstacles facing the diving and water sports sector and help in finding solutions to develop and improve the industry.

#### Fifth: The CDWS administration team:

One of the CDWS's greatest strengths is the ability to resolve the issues that the members are facing and working to preserve their rights within the framework of the relevant technical rules, laws, and resolutions. Accordingly, the board works directly with different state agencies to solve the issues and challenges facing the diving and water sports sector, and to achieve those objectives, a new administrative structuring for the CDWS team members was important to add experienced qualified candidates to the team, to carry out the duties and responsibilities of the CDWS and helps in offering a high level of administrative efficiency and achieve the CDWS desired objectives.

The CDWS team structure includes the following departments:

- Environmental department
- HR and training department
- Quality Assurance department
- Marketing, PR and communication department
- Membership administration department
- Information technology department
- Finance department

It is worth mentioning that these departments are constantly developed as per the needs and the service requirements of the sector.



 The CDWS has approved an amount of 120,000 Egyptian pounds (only one hundred and twenty thousand pounds only) for maintenance, replacement, and renewal of the moorings at the different diving sites in South Sinai to increase safety and security for users, the chamber in cooperation with the South Sinai National Park office have renewed, replaced and maintained 71 moorings in Sharm El Sheikh and Dahab to reduce the pressure of boat traffic on the dive sites in the months of May and June 2019. The moorings were funded by CDWS and installed using the help of 5 volunteering dive centers from the area. Noting that there is an obvious reluctance by the Ministry of Environment to install and maintain the moorings, which threatens the natural resources despite the many demands by the CDWS.

- CDWS has sought in several meetings with the officials of the Ministry of Environment and the Egyptian Tourism Federation representative to clarify the points of the legal and the serious damage that the decree no. 204 and no. 202 for 2019 will cause to the tourism sector, as it obligates the operations who are working in the field and are organizing touristic programs within the national park areas of South Sinai and the Red Sea (diving, snorkeling, safari, religious and cultural visits, boat trips and glass boats) in occasions to pay for the use of the activity fees, and in other occasions to pay the entrance fees every time, which will lead to charging twice for the same action or benefit which as a result charges duplicate fees of the entrance ticket in addition to the charge of the license (the use of the activities) unfortunately, all the attempts to reach solutions during the meetings held with the ministry have ended up unsuccessful. Therefore, and in order to save the best interest of the members and to avoid any damages against the tourism sector, CDWS has done the following:
  - In collaboration with the Egyptian Hotels Association, some diving centers, Safari boat companies, and hotels had filed two cases requesting urgently to suspend the implementation and, in the merits, to cancel the contested decrees. However, this path will not be decided before at least one year.
  - 2. The CDWS is trying to push the political direction in order to change this decision.
  - Coordinating with the Deputy Mohamed Abdel-Maksoud Deputy of the Parliament's Tourism Committee – to submit requests to inform both the Minister of Environment and the Minister of Tourism in this regard.





 Environmental Awareness Courses for the Diving and Snorkeling centers and Daily Boats are being developed. These free and compulsory courses will begin in mid-January 2020 for all diving and snorkeling and daily boats in both South Sinai and Red Sea Governorates. The courses will focus on plastic pollution awareness and how to reduce the negative impact on marine life through environmentally friendly practices. These courses are fully funded by the TVET project through the Egyptian Tourism Federation. Courses for the Water Sports centers will be developed in the second half of 2020.





CDWS would like to thank the members of the diving centers and the volunteer divers who organized cleanups campaigns, a beach clean-up in Nabq National Park for the World Clean-Up Day on the 21st of September 2019 as an initiative to support tourism and preserve the environment and natural resource, as well as another a dive clean-up in Travco Jetty partnering with the Greenish NGO on the 2nd of November 2019.

The Chamber urges everyone to follow the same approach and supports these orientations aimed at preserving the environment.

• The decision to prevent the implementation of all primary diving activities, whether under the name of DSD or Intro dive from buoys during any cruises in all locations along the coast, starting from Ras Mohammed reserve in the south to Taba in the north, and allowing this activity to be carried out by land only and from the beach.

Tourism in Egypt is based primarily on natural resources, therefore the CDWS requested from the Ministry of Environment to issue a decree aiming to stop the intro-dives who Indeed issued the decree, accordingly the CDWS board of directors issued a resolution in the meeting that was held on the 16th of October 2019 in regards to preserving the marine life. Which states that all Intro dives and DSD will be banned from all boats within along the coast starting from Ras Mohamed National Park (South) till Taba (North) and including all locations and sites of Tiran.

However, Intro dives and DSD are allowed only from land and from the diving locations along the beaches of the hotels and resorts. After the evaluation of the South Sinai National Park of each location individually to determine if it will be acceptable from an environmental aspect and defining the areas, the paths and the regulations of the implementation.

All diving centers interested in carrying out intro dives and DSD, shall submit a written request to the South Sinai National Park highlight the proposed coastal area and the suggested paths for those activities.

 The CDWS has also requested a decree from the Ministry of Tourism to suspended new license applications for diving, water sports centers and safari boats that's due to exceeding the maximum capacity of the coral reef environment in various areas except for kite and wind-surfing centers.





 The CDWS and The Reef-World Foundation have collaborated to bring green fins to Egypt, the only international sustainable eco-label for diving and snorkeling operators was introduced in Egypt by CDWS in October 2019. Green Fins is a voluntary certificate and management approach for centers to reduce their negative impact on the marine environment and help protect the environment by becoming positive role models. Green Fins is a management program created by the United Nations Environmental Program (UNEP) and managed internationally by the U.K based charity called Reef-World Foundation. In Egypt, the launch of Green Fins was funded by the Ministry of Environment and the United Nations Development Program through their joint project Mainstreaming Biodiversity in the Tourism Sector where CDWS is the main partner in the management of Green Fins nationally. With this great achievement, Egypt became no. 1 in the region and the eleventh worldwide to apply Green Fins initiative. the Green Fins initiative is optional and the CDWS recommends the members to join and implement the standards that allow them to obtain the Green Fins green badge, which is what the tourists are looking for when booking trips and activities as a sign for environmental protection, this contributes in advancing Egypt as a sustainable touristic destination between other competitors.

- Mr. Hesham Gabr the chairman of the CDWS met with Mrs. Yasmine Fouad the Minister of Environment to discuss environmental threats and wrong practices in diving and snorkeling areas, in light of complaints received by the Chamber from its members and civil society in Dahab about wrong environmental practices, to develop urgent solutions to existing problems with the aim of preserving the environment and natural resources. In which the Chamber requested that entering the "Bluehole" area to be limited only to diving activities. However, the Chamber was surprised by the decrees of the Ministry of Environment no. 202 and 204 of 2019 without consulting or getting back to the Chamber for an expert opinion.
- The Chamber, represented by its Chairman Mr. Hesham Jabr, attended several meetings on the environmental management plan in the Ras Muhammad and Sharm El-Sheikh region with the Ministry of Environment represented in the South Sinai National Park office, in which the CDWS and the Ministry the requests for licenses for water activities and the registered Maritimes were recorded, and legalizing them to operate in Sharm El-Sheikh, and to adjust the fee of the ride. However, this plan is still delayed by the Ministry of Environment to date for more than six months.



Training department report

from May 2018 till November 2019

With the aim of fulfilling the vision and the objectives of the Ministry of Tourism and CDWS to upgrade the diving and the water sports industry, services and facilities and to develop the human resources and technical knowledge. The Ministry of Tourism in collaboration with the CDWS and the Egyptian Tourism Federation's human resources training and development unit, have implemented a development strategy for the human capital in the tourism sector in Egypt from 2018 till 2023. The strategy is part of the TVET2 a co-funded project by the European Commission and the Government of Egypt. Based on the correspondence between CDWS and the Minister of tourism, it has been approved by the tourism fund to support the Egyptian Tourism Federation with an amount of LE 530,400 (only five hundred and thirty thousand and four hundred pounds), which is the estimated cost of implementing urgent training programs for the diving and snorkeling instructors working in the diving and water sports sector.









# Below is an overview of the training courses offered by the CDWS to its members:

#### First: Re-trainings for diving and snorkeling instructors:

Due to the low service level, high rates of accidents, low safety standards and the high failure ratio of the professionals who took the CDWS exams by a failure rate of 63%. The CDWS has utilized its resources to deliver 100 urgent re-training classes in South Sinai and the Red Sea governorates, with a total number of 378 trainees. As of the 15th of May 2018, to date, CDWS is keen to re-train the failed instructors to develop their performance and qualify them to keep pace with the future rapid changes in the industry.






# Second: Environment awareness sessions for safari boats crew:

A Total number of **46** environmental awareness training classes have been delivered to safari boat crews in South Sinai and the Red Sea governorates from February 2019 to date, with a total of **1508** attendees. Based on the CDWS evaluation for the need to train the boat crews on the correct guidelines in dealing with tourists and preserve the marine life which is the basis of the industry.





# Fourth: Technical manager training for diving centers and safari boats:

Due to the lack of specialized training on an international level to train and qualify technical managers for diving centers and safari boats, since the available courses only help in qualifying them to become diving instructors. CDWS designed the first round of the technical manager training for diving centers and




safari boats to ensure that they meet the international safety standards.

As of June 2019, to date, a total of 14 technical manager training were delivered in the South Sinai and the Red Sea governorates, with a total number of **152** attendees. It is part of the CDWS's future plan to design and execute different future courses to be taught by **ISO certified auditors** to serve and develop the technical, professional and managerial abilities of the technical managers working in the sector.







### The CDWS long-term training plan


#### in cooperation with the Ministry of Tourism and the Egyptian Tourism Federation:

- Support and develop the technical and professional education through applying a strategic executive plan for the human resources development in cooperation with the Ministry of Education, the Ministry of Higher Education, business owners such as hotel managers, tourism agencies managers and the diving and water sports centers managers with the aim of setting a strategy to develop the human resources in the sector.
- To address some of the professions in the sector that might affect the environment and the ecosystem, including:

operation, Receptionist, marketing, reservation and sales on several professional levels, helpers, cylinder assistants and maintenance technicians, deck hand, compressors handlers and diving equipment maintenance technicians, gas blenders, Sailing (kite) maintenance technicians, Diving guides and instructors, Snorkeling guides and instructors, Kite instructors, Safari boat chefs, captain, skipper and administrative managers. Specialized training for all previously mentioned professions were prepared in cooperation with the Egyptian government and the **European Union** through the **TVET 2** program - but not limited to – safety, security and risk management, environmental awareness, ISO 24803 quality standards for diving centers, training for compressor operators, compressed air sterilization, air compressors maintenance and developing the communication skills with tourists and visitors.







• Out of the CDWS keen interest in developing and upgrading the diving and water sports sector for its significant importance as part of the Egyptian national income and for the members best interest, the Chamber has issued:

- Manual and protocol of audits for the diving centers and safari boats.

- Manual and protocol of audits for the water sports centers (snorkeling services providers). Those protocols include all the phases and aspects of any performed audits to be an easy and reliable reference to facilitate the process, time and effort of the members.

• The quality assurance department has performed the below audits:

• In cooperation with the Ministry of Tourism, CDWS arranged a committee to audit the establishments and the boats before they depart the jetties, and while they are carrying out any water sports activity in the middle of the sea. The audits aim to ensure their compliance with the safety standards and the technical guidelines that should be followed by the facility. The audit campaigns for the Red Sea and South Sinai governorates for the period between the 13th of October 2019 till the 24th of November 2019 has been completed as follows:






Besides, the quality department has investigated 41 complaints submitted to the CDWS by the tourists or those working in the sector.


In order to protect the lives and the safety of the tourists and to sustain a high reputation of Egypt as a tourist destination, the Ministry of Tourism and the CDWS requested from the Chamber of Travel Agents and Tourism in South Sinai to communicate to their members who arranges trips to the national park areas whether it is Ras Muhammed, Nabq, Abu Galoum or any other beach sites by the coast of the Gulf of Aqaba (Inside or outside the national parks area), not to perform any diving or snorkeling activities unless it is through a MOT licensed operation according to the ministerial decree no. 444 for 2011. This to ensure the application of the rules, safety guidelines and quality standards approved by the ministry and the CDWS to ensure that those activities are supervised by qualified technical managers and that the diving and snorkeling instructors hold a valid CDWS ID card, are trained to perform first aid, C.P.R. and are aware of the use of medical oxygen tanks. This action comes as a result of several recent incidents in which tourists were subject to drowning, near-drowning and suffering injuries while swimming and snorkeling while visiting those areas.



Media, PR and communication report for 2019 1- The CDWS is working on launching its new website by 2020, with the purpose of developing the communication with the members to be fully electronic through the website services. With the aim that the website become the main platform for the information, duties, services offered by CDWS to the members as well as a guide for all diving and water sports activities.

3- CDWS held several meetings and negotiations with the Egyptian Tourism Authority regarding the participation in the 2019/2020 international shows and expos, which is one for the CDWS roles to help the members promote Egypt in the diving and water sports international shows in several countries such as England, Germany, France, Italy and the Netherlands.

In cooperation with the Egyptian tourism Authority, CDWS have been able to book a 50m space in Go Diving, the newest upcoming and strongest scuba diving show in Coventry – England. The show will take place between the 21st till the 23rd of February 2020. The space is available for 6 booths with a cost of 1600 euros each. The Reef-World Foundation and Chamber of Diving & Watersports (CDWS) have announced that Egypt is adopting the Green Fins environmental standards to help protect its coral reefs from the negative impacts associated with snorkelling and scuba diving. Egypt will become the first Middle Eastern country and eleventh nation worldwide to adopt the Green Fins standards.



Interview with Chice Harvey, Director of The Reef-World Foundation, about how the charity's implementation of the Green Fins initiative in Egypt-in partnership with the UN Environment Programme--is helping protect coral reefs in the Red Sea.
